International Charity Non-Government Organization «NART»

STATUTE

I. General Provisions

- 1.1. The International Charity Non-Government Organization «NART» (ICNGO «NART») is an international charitable, non-government, and non-profit public association.
- 1.2. ICNGO «NART» performs the activities all over the world through its representative offices and branches according to international laws, current local legislation and this Statute.
- 1.3. Organization's official languages are French and English.
- 1.4. ICNGO «NART» Headquarters address is Geneva, Swiss Confederation.
- 1.5. The validity period of this Statute is not limited.

II. Aims and Tasks. Types of Activities

- 2.1. ICNGO «NART» aims are as following:
 - 2.1.1. revival and development of minority nations, indigenous peoples, divided peoples affected by ethnocide and genocide, cultural and spiritual heritage and preservation of its national originality;
 - 2.1.2. realization of charitable and humanitarian actions with the object to strengthen the peace, friendship and consent between nations and to prevent social, national and religious conflicts;
 - 2.1.3. raising and accumulating of financial, material and other means and spending these resources for the accomplishment of the aims and tasks of the Organization.
- 2.2. ICNGO «NART» does not pursue the purpose to make profits. All received means, including but not limiting the incomes from commercial activities, should be used for covering the expenses for the implementation of the aims and tasks of the Organization only.
- 2.3. To carry out its statutory aims, ICNGO «NART» accomplishes the following tasks:
 - 2.3.1. organizes scientific researches and studies in economy, law, history, culture, education, demography, ecology and other fields connected with the revival and development of the minority nations;
 - 2.3.2. promotes of the study of native languages and the development of the programs and textbooks for national schools and educational institutions;

- 2.3.3. implements of various projects in the fields of publishing and mass media pertaining to the unity and the development of the minority nations, indigenous peoples, divided peoples affected by ethnocide and genocide;
- 2.3.4. promotes the preservation and development of national folklore;
- 2.3.5. participates in the revival, development and support of national crafts, mass public festivities and games;
- 2.3.6. collaborates with the other public organizations in the revival of national traditions, for the rescue and preservation of national historical and cultural monuments, landscapes, parks and memorable places;
- 2.3.7. fulfills the humanitarian actions including but not limiting the collection and distribution of humanitarian aid;
- 2.3.8. organizes and implements with charitable aims festivals, exhibitions, sports competitions, contests and fairs, as well as seminars, conferences and other actions including but not limiting travel and tourism programs;
- 2.3.9. institutes the ICNGO «NART» premiums, grants, diplomas, and etc.

III. Founders

- 3.1. All founders have equal rights and bear equal duties.
- 3.2. Resignation from the complement of the Founders is voluntary.

IV. Governing Bodies

- 4.1. The Governing body of ICNGO «NART» is the General Assembly of the Founders. The Assembly's meetings should be convened as required but not less than two meetings per one year.
- 4.2. The following are related to exclusive competence of the General Assembly:
 - 4.2.1. approval of Organization's Statute, entries in it of all modifications, changes, amendments and additions;
 - 4.2.2. decision on the termination and/or reorganization of the activities of ICNGO «NART»;
 - 4.2.3. decision on the participation of ICNGO «NART» in the other public associations, unions and associations and/or on quitting with them;
 - 4.2.4. formation of Organization's Board of Trustees;
 - 4.2.5. approval of ICNGO «NART» Regional Representative Office/Branch Regulations;
 - 4.2.6. decision on the opening of Regional Representative Office/Branch;
 - 4.2.7. appointment of ICNGO «NART» Director General (CEO);
 - 4.2.8. approval of Organization's annual plan and annual budget;
 - 4.2.9. approval of ICNGO «NART» Directorate General's annual report.
- 4.3. The General Assembly is competent to reach decisions by the simple majority of votes. Each Founder has one vote.

- 4.4. To assist ICNGO «NART» activities, to help in realizing and inspecting purposeful programs the Founders form the Board of Trustee for the period of 5 (five) years from authoritative individuals, who are supporting the statutory aims and tasks of the Organization. The number of Trustees is not limited. Board of Trustee elects the Chairman of Board, which convokes Board meetings as required and presides over them.
- 4.5. The Board of Trustees:
 - 4.5.1.assists in working out the concept of the development, definition of the main activities, and in the preparation of long-term programs of ICNGO «NART»;
 - 4.5.2.recommends the most effective ways of utilization of the resources of the Organization;
 - 4.5.3.oversees the observance of legislation and this Statute in the conduct of business of ICNGO «NART», of its regional representative offices and branches.
 - 4.5.4.scrutinizes other questions, the decisions over which have the nature of recommendation.
- 4.6. The Director General (CEO) of ICNGO «NART» is appointed by the Founders for the period of 5 (five) years. His competence is as following: to develop ICNGO «NART» Programs; to manage all Organization's properties and means;
 - 4.6.1.to have the right of the first signature on the financial and other documents of ICNGO «NART» including the Powers of Attorney;
 - 4.6.2.to coordinate the functioning of ICNGO «NART» subdivisions;
 - 4.6.3.to form the stuff of Directorate General.
 - 4.6.4.to coordiante the activities of sub divisionel strucktures of ICNGO «NART».
 - 4.6.5.to name the effective cadres of the general directored.
 - 4.6.6.to resolve other problems of ICNGO «NART» activities not included in the exclusive competence of other bodies;
 - 4.6.7.to report to the Founders about his work and to bear the responsibility for the accomplishment of the aims and tasks of the Organization.
 - **V. Structure**
- 5.1. ICNGO «NART» structure consists of the Directorate General, and Regional Representative Offices and Branches opened in the different countries.
- 5.2. Regional Representative Offices and Branches of the Organization are founded by the resolution of ICNGO «NART» General Assembly and operate according to this Statute and Representative Offices/Branches Regulations. In the conduct of their daily activities decisions and recommendations of the Organization's Governing Bodies guide the representative offices and branches.
- 5.3. The supervision of ICNGO «NART» regional representative offices and branches should be carried out on the Power of Attorney basis of by the Heads of Regional Representative Offices/Branches appointed by Director General (CEO).

VI. Properties

- 6.1. Properties of ICNGO «NART» are formed from the following sources:
 - 6.1.1.payments and contributions of Founders;
 - 6.1.2.charitable donations including but not limiting the funds earmarked for special purposes and provided in cash or paid in kind;
 - 6.1.3. incomes from commercial and other activities of the Organization;
 - 6.1.4.other receipts not forbidden by laws.
- 6.2. The incomes from commercial and other activities of ICNGO «NART» cannot be shared among the Founders and can only be used for the implementation of the Organization's statutory aims and tasks.

VII. Reorganization and/or Liquidation

7.1. Reorganization (merging, acquisition,, division or re-organization) and/or liquidation of ICNGO «NART» should be carried out in the order stipulated by the legislation.
